 - I. President calls the meeting to order at 9:00 am
 - a. The president requested monthly evaluations a day or two prior to the BoD meetings
 - b. The ARC request process should be done in a timely manner and the board members are in agreement with the approvals.
 - c. The board should be fully involved with approvals of violations and requests.
 - d. The floor was opened to comments from those wanting to be on the ARC
 - e. Prior to open discussion, the president reminded everyone of meeting decorum and etiquette discussed at the previous BoD meeting.
 - i. Scott Leierer defended his position on the ARC committee stating his decisions in the past have always been based on his knowledge of the Covenants, By-laws and FL statues.
 - ii. Gary Scamehorn emphasized how important it was to educate potential homeowners through real estate agents and re-educate current homeowners about the ARC and the process for approving forms and requests. Janice Scamehorn is open to be on the ARC, but not as the chairperson. She stated that the decisions are made based on the Covenants and FL statutes.
 - iii. Steve Santangelo volunteered to be on the ARC
