## I. Treasurer's Report – Dena Stone

- a. HOA dues

  - g. The storm drains along the curb are in need of repair. Gary Roth will contact someone from the city to address this.
  - h. The south fence needs repair.

  - j. The storage unit must be inventoried. Some, if not all files, will have to be digitized as they may need to be kept indefinitely. Backup files and accessibility are crucial
