B. Presidents' Report

- 1. Phil Barry officially resigned on June 1, 2022. Jacqueline Leierer will be acting President till the next election in December
- 2. Jim Donner officially resigned on July 10, 2022. Which leaves us with just 1 board meeting. We need a minimum of 2 board members to conduct business.
- 3. Mary Lynn Krause (3936) has volunteered to become a board member till the December elections.
- 4. Janice has volunteered for the open Secretary position. A vote was taken and passed 2-0 to accept her offer of Secretary starting August 1, 2022.
- 5. Status of MRTA application from Attorney
 - a. Jacqueline has been in talks with the lawyer and we are in the final stages with the paralegal before it moves on to the lawyer.
 - b. It is asked the community to stop spreading rumors about the HOA and if you have any questions to ask the board members.
